









Anti-Ragging committee meeting was held on Friday, 25th March 2019 at 04.00 pm at conference room.

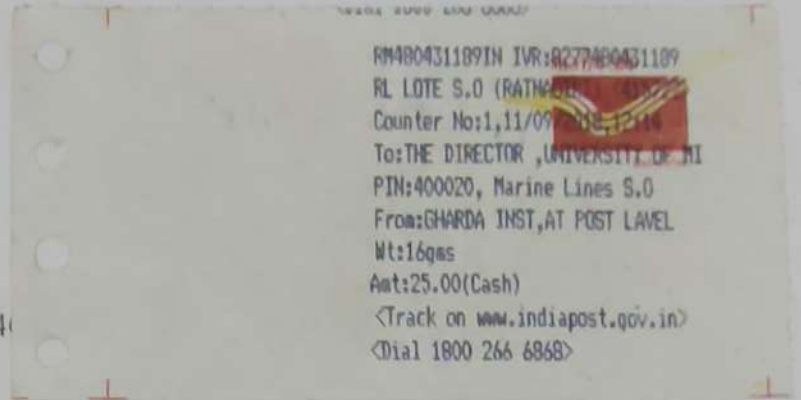


