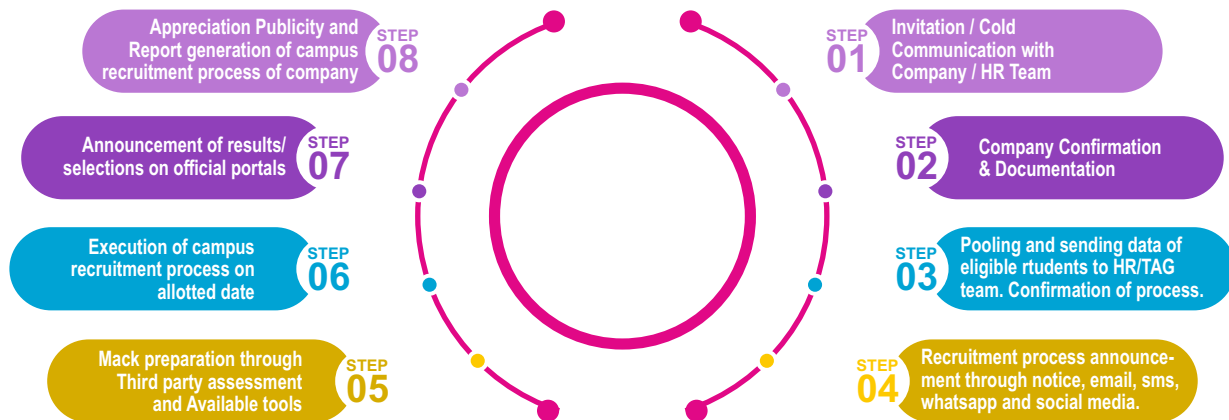

#### 9. **ADMISSION PROCESS AND BENEFICIARY SCHEME**

Candidates are advised to follow the rules for admission to Under Graduate & Post Graduate degree course as published by the Directorate of Technical Education / State Common Entrance Test Cell, Maharashtra State on their website (<http://www.mahacet.org>) from time to time. Refer DTE information brochure 2026-27 for detailed rules of admission.

##### 9.1 **Additional seats available under AICTE Tuition Fee Waiver Scheme**

Under Economically Weaker Section Scheme 10% seats per course of sanctioned intake shall be available for First Year Engineering admissions.

##### **Salient Features:**

- i. Sons & daughters (only Maharashtra State candidates) of parents, whose annual income is less than Rs.8.00 lakhs from all sources are eligible for admission under this scheme.
- ii. The waiver is limited to Tuition Fee only as approved by Fee Regulating Authority for the concerned academic year. All other applicable fees except tuition fees will have to be paid by the beneficiary.
- iii. The beneficiary shall not be allowed to change institution/course under any circumstances.

##### 9.2 **Cancellation of admission**

The candidate taking admission have to pay necessary fee and submit all original certificates / required documents on the day of admission. In case candidate fails to pay total fees and/ or fails to submit any of the original documents within the allowed time limit, the admission shall be treated as cancelled. Refund of fees shall not be applicable in such cases.

##### 9.3 **Refund of fees after cancellation of admission**

Refund will be made as per Admission Regulating Authority's/DTE Rules.

#### 9.4 **E.B.C. Concession (applicable Only For CAP Quota Admissions)**

Candidates, who are eligible to claim concessions for Economically Backward Class (EBC) have to produce a certificate from the Executive Magistrate (Tahasildar) to the effect that he/she belongs to EBC category. Such candidates shall also have to submit an application form (on-line and/or off-line, as declared by competent authority) through the college as notified from time to time. The students shall note that applications received after due date will not be considered for EBC concession. Students with attendance less than 75% will not be eligible to claim EBC and will have to pay total fees.

#### 9.5 **Concessions for Sons & Daughters of Teaching and Non-Teaching Staff of Primary, Secondary and Higher Secondary Schools:**

Not applicable in case of our institute.

#### 9.6 **Concession in Fees for Backward Classes Category Candidates belonging to Maharashtra State only (Applicable only for CAP quota admissions)**

As per relevant circulars from the Social & Tribal Welfare Departments, Govt. of Maharashtra, Backward Class category candidates belonging to Categories as declared by Admission Regulating Authority's, Maharashtra State securing admission to un-aided private institutes through CAP rounds only are eligible for obtaining reimbursement of the fees approved by the Fee Regulating Authority (FRA), Maharashtra State. However, these candidates will get re-imburement of the fees to the extent of waiver, as notified in the circulars issued by the Social Justice & Welfare Departments from time to time, subject to fulfillment of various norms and conditions laid down by these departments.

##### **Notes:**

1. Students claiming fee concession under reserved category shall have to produce all the required certificates as specified by the respective Social Justice & Tribal Welfare Department.
2. The students shall be required to pay all the University fees as prescribed by the University from time to time.
3. The students, who fails to fill up scholarship/Free-ship application and also fail to submit the same for what soever reason to institute before last date declared by the Govt. will have to pay total fees irrespective of their caste.

#### 9.7 **Seats for Admission**

##### **(1) First Year**

The seats remaining vacant after reporting of candidates from CAP rounds, shall be filled in by the institute in Institute Level round i.e. Vacancy Round, subject to such permission given by Government.

##### **(2) Direct Second Year**

The seats remaining vacant after reporting of candidates from all CAP rounds, shall be filled in by the institute under Against CAP seats, subject to such permission given by Government.

#### 9.8 **Allotment of Course**

Allotment of course for Institute Level seats will be made on "Merit-cum-Option" basis.

#### Important Notes:

- a. All students must always carry with them three sets of attested photo copies of all above documents and recent passport size colour photographs.
- b. A candidate must be medically fit to undergo the professional course applied for. The medical fitness must be certified by a Registered Medical Practitioner in the prescribed proforma and to be submitted at the time of admission.
- c. All the students must submit print-out of on-line anti-ragging affidavit (Website: [www.antiragging.in](http://www.antiragging.in)/[www.amanmovement.org](http://www.amanmovement.org))
- d. A student must inform changes, if any, in Contact Numbers, Postal Address, Email ID, etc. to Academic Section in writing during education in college.
- e. If University of Mumbai prescribed any additional condition/s about eligibility for Diploma holders to degree courses in engineering, the same shall also be applicable for admission.
- f. All admissions are provisional & subject to final eligibility certification from concerned university and final approvals by Admission Regulating Authority, Maharashtra state. If Admission Regulating Authority dis-approves admission, the same may be cancelled at any stage.
- g. The medium of instruction for degree course is English.
- h. The Admission of all the students other than those who have appeared in Maharashtra State Board of Higher Secondary Examination to any courses at the college will be confirmed only on production of the Eligibility Certificate from Mumbai University.
- i. Notwithstanding anything stated in this prospectus, Rules made by state CET Cell,

Govt. of Maharashtra shall prevail.

## 10. GENERAL RULES FOR STUDENTS

- 10.1 Dress Code:** All students must be properly dressed, which is a mark of respect to the august place of learning. Any violation will be considered as an act of in-discipline. Students will be advised about dress code for specific events from time-to-time.
- 10.2 Use of Mobile:** Use of mobile for any purpose and in any way is prohibited in academic area. Violation will be considered as an act of indiscipline.
- 10.3 Identity Card:** All the students must hold valid identity card around neck while in the college premises. Student without identity card may be considered trespasser and dealt with accordingly.
- 10.4 Prohibited Area:** Entire GIT campus is a prohibited area for possession of weapons, drugs, liquor, spirit, cigarette, beedi, gutkha, tobacco, etc. in any form.
- 10.5 Loitering:** Loitering around is not allowed in the academic, administrative, mess and cafeteria area. During free time, one is expected to be in the library, in recreation areas and hosteller students in hostel room.
- 10.6 Campus Code:**
- a. General behavior of a student must be polite and courteous at all times. Arguments and demands with mess, cafeteria staff, vendors, staff, faculty, in public places or with public, over telephone, etc. should be avoided.
  - b. Any conduct or behavior unbecoming of a student or good citizen shall attract intervention and action. It has been observed that the Institute students by virtue of their numerical strength are sometimes involved in cases of physical violence or nuisance at public places outside/ inside the institute campus. In all such cases the college is not legally bound to defend any student or to take bail, etc. If the necessity arises, the Institute authorities may inform the guardian/parents of the students involved in such incidents. The responsibility of defending the cases will be entirely of the concerned student/s. Students shall be responsible for their actions. No student shall be above the Law. The hostel cannot be considered as a hiding place for miscreants. Parents are advised to guide their wards so that they don't indulge in any physical violence.
  - c. Principal, Registrar, Warden and /or his/her authorized representatives can conduct regular and surprise checks in the hostels including rooms at any time for monitoring adherence to these orders and also to monitor attendance. All the students shall remain present at the time of daily roll call.
  - d. No girl student or any women shall enter boys hostel and vice versa except staff members carrying out official duties such as inspection, repairs etc. that too with permission from authority.
  - e. Security staff and institute staff are hereby authorized to check violations of these rules and enforce adherence. No argument with them is permissible on the norms, which are clearly spelt out.
  - f. Students are advised not to keep any valuables such as gold, silver, diamond ornaments, cash, mobile, etc. in the hostel rooms. Institute is not responsible for damage or theft.

- g. Students are responsible for their belongings. They are advised to keep all their belongings under lock and key all the time.
- h. Non-adherence of the given rules will attract disciplinary action to the extent of termination of student ship from the institute.

**10.7 Health Care:** Institute provides first level medical attention and can arrange for expert attention and consultants, as required. In case of emergency, the hostel warden can extend assistance and make arrangement for hospitalization. Full time Counselor is available to take care of mental stress of the students.

### 10.8 Termination of Studentship

Termination of studentship without notice will happen in following case/s:

- a. Stealing or indulging in malpractice in examinations or tests.
- b. Sexual misconduct inside or outside the campus.
- c. Found inside the campus intoxicated or after consumption of liquor/ drugs.
- d. Found smoking in the campus including inside the hostel rooms.
- e. Willful damage to institute property.
- f. Indulging in violence against anyone.
- g. Not clearing the examination according to the rules.
- h. Violent behavior/ assaulting others inside the campus.
- i. In case a student continues to indulge in misconduct even after two cautions / warnings.
- j. Allowing other students/persons to stay in hostel rooms.
- k. Psychological abnormality.

## 11. ATTENDANCE AND DISCIPLINE

- a. Every student must complete, to the satisfaction of the rules of Mumbai University, the courses of study at the College prescribed for such term for the class to which the student belongs. The student must keep a minimum attendance of three-fourth (75%) of the number of days on which lectures and practical are held in each term. While deciding defaulters in attendance, Ordinance 6086 of University of Mumbai will be strictly followed as guideline.
- b. There will be an examination at the end of each semester. The examinations at the end of Semesters I, II, VII and VIII are conducted by the University. The examinations at the end of semesters III, IV, V and VI are conducted by the College on behalf of the University according to the University Rules.
- c. The GIT Management, along with the paternal involvement, is committed to a healthy discipline and high academic standards of the College, and the students are required to co-operate maintaining the same.
- d. University Ordinance 0.6086 Attendance for learners: Every bonafide learner shall ordinarily be allowed to keep terms for the given semester in a program of his enrollment only if he/she fulfills at least seventy five percent (75%) of the attendance taken as an average of the total number of lectures, practicals, tutorials, etc. wherein short and/or long excursions/field visits/study tours organized by the college and supervised by the teachers as envisaged in the syllabus shall be credited to his attendance for the total no. of periods which are otherwise delivered on the material day/s. Further it is mandatory to every learner to have minimum 50% attendance for

each course and average attendance has to be 75%.

## 12. PREVENTION OF RAGGING IN TECHNICAL INSTITUTIONS

- a. "Ragging is prohibited as per the decision of the Hon'ble Supreme Court of India in Writ Petition No. (C) 656/1998" as well as subsequent notifications issued by the AICTE and Mumbai University. Students indulged in ragging in any form in the College campus or in the vicinity will be strictly dealt with and punished including expulsion from the college, as per the provisions of the Maharashtra Prohibition of Ragging Act 1999 and other legislation as may be applicable. Students will abide by UGC regulations 2009 in respect of prevention of ragging.
- b. The student will be denied admission if he/she is found indulged in ragging earlier OR if it is revealed subsequently after admission that was indulged in ragging, he/she will be rusticated from the college, as per the Govt. circular dated 18th July 2007 pursuant to Hon'ble Supreme Court Judgment in regard to enforcement of anti-ragging measures.

## 13. PLAYING WITH COLOURS/OTHER MATERIALS

Playing with colours or any other material inside the College campus (including Hostel) or in the vicinity or adjoining places outside the College campus during the festivals is strictly forbidden. Students found indulged in such activities are liable for strict disciplinary action. Use of crackers or explosives is completely prohibited.

### DECLARATION

- a. In Gharada Institute of Technology & Management all provisions in respect of Anti-ragging Act and Anti-capitation Fee Act have been made and implemented.
- b. Management has created barrier-free environment for its institute blocks on Ground Floor, toilets all over the Institute and Sanitary Blocks for Physically Challenged Students.
- c. Management has adequate safety provisions including fire-fighting equipment in the form of fire extinguishers at different locations.
- d. Management is discouraging & preventing students from consumption of tobacco and other intoxicating substances within institute.

For maintaining safety, discipline and academic atmosphere, there is strict and close surveillance of security system, warden & higher authorities.

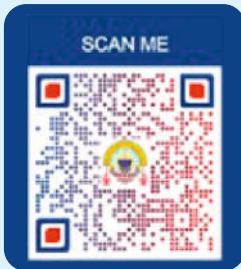

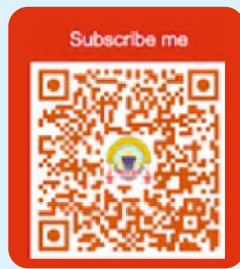

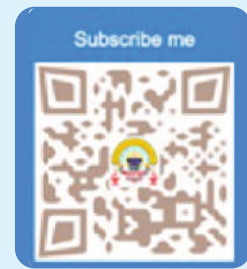
